OFFICE CLOSURES EXTENDED TO FEBRUARY 19TH, 2021

Chief and Council, along with the Senior Management Team, has determined that all Garden River First Nation offices will remain closed until **February 19th, 2021** with the possibility of an extension. This includes the closure of the Child Care Center, the closure of the JK/SK Program, the cancellation of all student transportation services and AIM learning will continue on-line with no in-person instruction.

This decision was made to coincide with Provincial State Of Emergency, the Stay At Home Order in effect and Algoma District will remain in Stage 1 Lockdown until this time.
